# **2022 Covid Game Rules**

- **14 minute stopped clock halves, All OTs are 1:30 with no additional time outs, but can carry over 2<sup>nd</sup> half ones over.**
- **2 :60 second time outs per half. They do not carry over**
- **Double Bonus at 10 fouls. 5 fouls per player**
- **No pressing or back court guarding any time the score is +20. Clock runs final 5 minutes of the second half when score is over 20 points**
- **EBA will be charging \$5.00 admissions for adults. \$2.00 8-16 years old. Teams are allowed 2 coaches + 1 Score/Book keeper in for free. No weekend passes**
